


COMMUNITY PROFILE

The Rural Community of Fundy Shores covers the communities of Chance Harbour, Dipper Harbour, Lepreau, Little Lepreau, Maces Bay, Musquash, New River, Pocologan and Prince of Wales. Each community having its own identity, special attributes and strengths.

The Rural Community is located in the southwest portion of the Province of New Brunswick, approximately 15km west of the City of Saint John. With a population of 2100 citizens covering a landmass of approximately 350 square kilometers.

For its first year, the Rural Community had one full-time staff member which worked to establish service contracts, transfer departments from Provincial oversight back to the local community. With Council they helped develop a strategic plan and identify needs of the community.

PROPERTY TAX BASE & RATES

Property Tax Base

All real property in the province is assessed annually for taxation purposes on the basis of its real and true value. Real Property is classified as either residential property (owner-occupied, non owner-occupied or other residential) or non-residential property. The total of all property assessments provides the property tax base which is used in a formula to set the tax rate for the community based on the services it provides. A tax base ratio is also added to non owner-occupied and non-residential property. The ratio can be 1.4 - 1.7. Fundy Shores ratio is set at 1.7

Property Tax Rate

Every fall, Council works to establish a balanced budget, the budget is based on the cost of operating each department and contract owned by the rural community. Some costs Council has a great deal of input into budgeting, however, some items Council is told by other levels of government what they expense shall be. Once all the expenses and revenues are taken into account, the final outstanding amount is known as the warrant. That is the amount that is charged against real property in the form of a tax rate.

Fundy Shores Elementary

Roots of Empathy - \$1000

The Roots of Empathy program is delivered to elementary school children. Through guided observation the children label the baby's feelings and intentions, learning the affective aspect of empathy (emotion) and the cognitive aspect of empathy (perspective-taking). In Roots of Empathy, emotional literacy develops as children begin to identify and label the baby's feelings, reflect on and understand their own feelings, then bridge to understand the feelings of others.

Without the donation from Fundy Shores, this program would not have been accessible at the local Elementary School.








HIGHLIGHTS

Community Engagement

In early 2023, Council began hosting community engagement sessions to identify the needs/wants of the community and develop a strategic plan. Over the course of three months events were held and a plan was developed and presented to Council. The strategic plan created a vision and mission statement and identified six pillars for growth.



Fire Department

Council worked with the Musquash Fire Department and the Province of New Brunswick to transition the Fire Department from a Provincial Resource to a partnership between Fundy Shores and Musquash Fire.

Contract Negotiations

In October 2023, Council negotiated the new terms and conditions for solid waste collection in Fundy Shores. This saw the contract costs transition from \$554,539 to \$228,189 for 2025 (2024 will be a transition year on the contract from Provincial to Fundy Shores.)

Rural Plan Update

In the Summer of 2023, Council tasks the Regional Service Commission to update the Rural Plan By-Law for Fundy Shores. Currently, two separate planning acts governing development in Fundy Shores, the new plan would cover the entire area and treat it uniformly. Proposed completion date on this project is mid 2024.
