# 10. Correspondence

# a. Regional Service Commission - Tipping Fees

Hollis Bartlett, CEO of Southwest New Brunswick Service Commission (SNBSC) advised Council of the change to the cost per tonne for solid waste collected in the region. The price per tonne is being reduced from \$92 to \$72 per tonne. The Board of Directors approved the reduction due to a surplus experienced primarily from deposit of foreign waste at the landfill facility. The \$20 per tonne reduction is being used to eliminate the recycling surcharge that was applied with the recycling program was first introduced. Mr. Bartlett is comfortable that the reduction can be experienced year over year.

b. **Proclamation** Mayor Cogswell received a request to proclaim May 2023 as Lyme Awareness Month. They also requested, if possible, Fundy Shores light up a structure of our choice in green or a green spotlight for the month.

## c. Canada Community - Building Fund

Minister of Local Government and Local Government Reform, Daniel Allain issued a memo on March 13, 2023 confirming \$6.75 million has been earmarked for new entities affected by Local Government Reform.

#### d. Atlantic Canada Opportunities Agency

Mayor Cogswell received a letter from Ginette Petitpas Taylor, MP and Minister responsible for Atlantic Canada Opportunities Agency (ACOA), congratulating him on the election and offering information on ACOA programs and providing the contact information for the local ACOA office.

#### 13. New Business

a. Right to Privacy and Protection of Personal Information Appointment Under the Right to Information and Protection of Privacy Act, a "head" whose responsibility is to ensure the act is followed and is responsible for any request needs to be appointed by by-law or resolution. Due to staffing size, it is recommended that Council appointed CAO Sullivan Brown to fulfill that role.

#### b. Lottery License

With the organizational changes from municipal reform and subsequent meeting with the Musquash Recreation Committee. The activities of the Musquash Recreation Committee are now under the structure of the Rural Community of Fundy Shores. One activity (bingo), host monthly, requires Fundy Shores to obtain a Lottery License. Council will need to grant permission to CAO Sullivan Brown to obtain a license in their name and define where any net proceeds from the lottery are invested in services moving forward. Cost of the application is \$50.

## c. Regional Service Commission - Building Inspector Appointment

The Southwest New Brunswick Regional Service Commission (SNBRSC) has a new qualified inspector, Mr. John Cliff (Level 1). Mr. Cliff needs to be appointed to the roster of inspectors allowed to conduct services on behalf of the SNBRSC. Depending on the Level of Inspector dictates what type of inspection they are allowed to conduct.

Building Inspectors that are Level 1 are qualified to review and inspect residential buildings under Part 9 of the National Building Code 2015 ("Code"). If they do not

have full Building Code Qualified Official 1 status, then their training work can be supervised/signed-off by higher-level inspectors.

Building Inspectors who are Level 2 are qualified to review complex Part 9 buildings like multi-unit residential and some commercial buildings.

Level 3 inspectors are qualified to review any building under Code, which includes hospitals, churches, large commercial or industrial buildings.

## d. Recreation/Leisure Library User Policy

A requirement for the safe operation of the Recreation/Leisure Library is the responsible collection of personal information and advisement of user responsibilities and any potential safety issues. Attached to tonight's agenda is a copy of a draft policy.

#### e. Recreation/Leisure Library Phase 2

Regional Development Corporation has a Community Investment Fund that allocates \$50,000 per electoral riding each fiscal year. Funding is granted at 100% dollars up to \$5,000 and 50% up to \$10,000 per project. CAO Linda Sullivan Brown is requesting permission to apply to this fund as Phase 2 of the Recreation/Leisure Library to enhance access to active living in Fundy Shores. This project will require a small financial commitment from Fundy Shores in the amount of \$605.96 and inkind support of \$2050.00.

## f. Live Streaming Council Meetings

Live streaming of Council meetings has been a topic of discussion in recent weeks. Council will need to make a determination if they wish to see their meetings livestreamed or not, or which meetings they wish to live stream. (Depending on results, staff can order the appropriate materials.)

## g. Mileage and Meal Allowances

CAO Sullivan Brown reached out through the AMANB List Serve to ask how mileage and meal allowance rates were determined. Almost all organizations that responded use the Provincial Mileage Rate and Meal Allowance rate of \$0.50/km and Breakfast \$10.25; Lunch \$14.25 and Dinner \$26.60 for a total daily allowance of \$51.20; incidentals \$5.00/day. Fewer referenced the National Joint Council at \$0.57/km; Breakfast \$22.80; Lunch \$23.05; Dinner \$56.60 for a total daily allowance of \$102.45 misc. incidentals (parking, long distance calling etc.) \$17.30/day.

The requirement of receipts varied amongst the organizations. Some organizations just require proof of travel.

Council will need to decide how they wish to proceed.
