2025.04.02.45 Moved by Councillor Dealy, **seconded** by Councillor Saulnier that be it resolved to provide the second reading of by-law B-2-2025, A By-Law Respecting Dog Control in the Rural Community of Fundy Shores by title, "Dog Control By-Law," and summary:

"Council for the Rural Community of Fundy Shores, under the authority vested in it under the Local Governance Act makes the following by-law respecting the control of Dogs for the Rural Community of Fundy Shores (herein called the by-law):

- 1. By-law No. B-2-2025
- 2. This by-law may be cited as the Dog Control By-Law
- 3. This by-law applies to the Rural Community of Fundy Shores government boundaries as outlined in subsection 68 of Regulation 2022-50 under the Local Governance Act.
- 4. This By-law:
 - i. Defines ownership of dogs
 - ii. Identifies dog control officers
 - iii. The vaccine and registration requirements of dogs in Fundy Shores.
 - iv. Rules associated with housing and keeping of dogs in Fundy Shores.
 - v. Seizure of dogs at large, rabid, aggressive/dangerous dogs in Fundy Shores
 - vi. Tranquilization and if necessary in opinion of a licensed vet the humane euthanasia of dogs.
 - vii. And prohibitions and penalties for contravention of the by-law.
